- Directions:** The Joe Foss Shooting Complex is located in the Buckeye Hills Regional Park. The Park is located about 10.5 miles south of I-10 on S.R. 85 at mile post 144.
- Competition Open to:** All shooters of all experience levels. All competitors must have a notarized "**Eligibility Affidavit and Liability Agreement**" on file at the Joe Foss Shooting Complex or present at time of registration
- Entry Fee:** \$15.00 per entrant
- Start Time:** Gates open and check-in starts at 06:30 A.M.
Range safety briefing at 07:00 A.M.
Match begins promptly after safety briefing
- Rifles, Ammo & Equipment:** This is a John C. Garand match, following CMP competition rules open to:
- M1 Garand
 - M1903 Springfield
 - M1917 Enfield
 - M1914 Johnson
 - .30 cal M1 Carbine
 - US Krag Rifle

*** "Non-sanctioned rifles: AR15, M1A1 or any other magazine fed rifle will be allowed in this match, but the results will not be reported to the CMP

All shooters are required to provide their own ammunition, however, no tracer or armor piercing ammunition is allowed. Bring water, binoculars or spotting scopes, shooting mat, shooting glove, **safety glasses and ear protection are mandatory.**

- Course of Fire:** John C. Garand Match – Course B
- 200 Yards Slow Fire Stage – Prone (25 minutes –Incl. time for unlimited sighter shots)
 - 200 Yards Rapid Fire Stage – Prone from Standing (70 seconds)
 - 200 Yards Rapid Fire Stage – Sitting or Kneeling from Standing (60 seconds)
 - 200 Yards Slow Fire Stage – Standing (10 minutes)
